I'm reaching out today to offer some assistance as you prepare to return to Wabash in August.

The Coronavirus Aid, Relief, and Economic Security (CARES) Act includes a Higher Education Relief Fund (HEERF), which provides emergency grants to students for expenses related to the disruption of campus operations as a result of the coronavirus. You may apply for grants if you experienced expenses due to the disruption. Examples of expenses include food, housing, transportation, course materials, technology, and office supplies.

These emergency grants are non-renewable and must be cash awards given directly to students. Applications will be considered on a first-come, first-serve basis until the funding is depleted. Complete your application for HEERF funds here.

A FAFSA is not required to access these funds. However, you must meet the <u>general student eligibility requirements for Federal Student Aid</u>. If you do not meet the general student eligibility requirements, you may complete the <u>Student Support Funds application</u>.

The deadline to complete the application is July 6, 2020. You should be notified by email within two weeks after the submission deadline. Funds will be disbursed via direct deposit if your application is approved. <u>Login to your Wabash Self-Service account to sign up for direct deposit</u> if you haven't already done so.
